#### Feedback Received:

#### Unions:

- Confirmation of proposed pay award being included in the draft budget
- Noted uncertainties around adults/childrens services challenge of funding the gap longer term
- Sought clarity on the Council reserves
- Sought clarity on the discretionary inflation for contracts
- Raised issue with Babcock cutting services
- Council should recognise positive approach of the workforce

#### Schools/Schools Forum

- Acknowledgement of the ESG funding/growth proposed
- Pressures experienced by schools in terms of general level of funding
- Concerns about "losers" in the proposed new funding formula

### **Voluntary and Community Sector/Parish Councils**

- Acknowledged really difficult position the Council finds itself in
- Described the increase in council tax as "brave"
- Noted adults services demand was the amount put in the budget for demographics enough? (A number of comments saying the same thing)
- Raised the demands on carers
- Lobbying needed for better deal on Adult social care funding
- · Wanted recognition of the costs of volunteering

#### **Businesses**

- Really supportive of working with Children Families and Communities to support mentoring / shadowing / apprenticeships to help to combat the inter-generational issues with looked after children
- Would like the Council to invest in initiatives like "Be your own boss" this supported young
  adults to develop employability skills and was particularly aimed at vulnerable young people
  which helped to reduce the number of NEETs
- Liked the idea of Revolving Investment Fund, and would like to understand more and whether this idea could be developed further
