#### **DISCLOSING INTERESTS**

#### There are now 2 types of interests: 'Disclosable pecuniary interests' and 'other disclosable interests'

#### WHAT IS A 'DISCLOSABLE PECUNIARY INTEREST' (DPI)?

- Any **employment**, office, trade or vocation carried on for profit or gain
- **Sponsorship** by a 3<sup>rd</sup> party of your member or election expenses
- Any **contract** for goods, services or works between the Council and you, a firm where you are a partner/director, or company in which you hold shares
- Interests in **land** in Worcestershire (including licence to occupy for a month or longer)
- Shares etc (with either a total nominal value above £25,000 or 1% of the total issued share capital) in companies with a place of business or land in Worcestershire.

#### NB Your DPIs include the interests of your spouse/partner as well as you

#### WHAT MUST I DO WITH A DPI?

- Register it within 28 days and
- **Declare** it where you have a DPI in a matter at a particular meeting
  - you must not participate and you must withdraw.

NB It is a criminal offence to participate in matters in which you have a DPI

#### WHAT ABOUT 'OTHER DISCLOSABLE INTERESTS'?

- No need to register them but
- You must declare them at a particular meeting where: You/your family/person or body with whom you are associated have a **pecuniary interest** in or **close connection** with the matter under discussion.

#### WHAT ABOUT MEMBERSHIP OF ANOTHER AUTHORITY OR PUBLIC BODY?

You will not normally even need to declare this as an interest. The only exception is where the conflict of interest is so significant it is seen as likely to prejudice your judgement of the public interest.

#### DO I HAVE TO WITHDRAW IF I HAVE A DISCLOSABLE INTEREST WHICH ISN'T A DPI?

Not normally. You must withdraw only if it:

- affects your pecuniary interests OR relates to a planning or regulatory matter
- AND it is seen as likely to prejudice your judgement of the public interest.

#### DON'T FORGET

- If you have a disclosable interest at a meeting you must disclose both its existence and nature - 'as noted/recorded' is insufficient
- Declarations must relate to specific business on the agenda
  - General scattergun declarations are not needed and achieve little
- Breaches of most of the **DPI provisions** are now **criminal offences** which may be referred to the police which can on conviction by a court lead to fines up to £5.000 and disqualification up to 5 years
- Formal dispensation in respect of interests can be sought in appropriate cases.

# SUPPORTED EMPLOYMENT FOR PEOPLE WITH LEARNING DISABILITIES

#### Summary

- 1. The Adult Care and Well Being Overview and Scrutiny Panel will receive an update on the service and support provided to help people with learning disabilities access employment pathways.
- 2. Representatives from the Directorate of Adult Services have been invited to the meeting.
- 3. The Panel will also have the opportunity to hear from people who have been supported into/been able to sustain employment.

#### **Background**

- 4. Supported employment for people with learning disabilities was added to the Panel's work programme following an update on Learning Disability Day Services in May 2016. More recently this area was suggested as an area for scrutiny by this Panel, as part of the over-arching Overview and Scrutiny Performance Board's update on the Council's responsibilities and work on equality and diversity.
- 5. Learning Disability Services is provided through an integrated service, where the Council's Adult Services Directorate work in partnership with Worcestershire Health and Care NHS Trust.
- 6. The Supported Employment Service is based within the Adult Services Commissioning Unit. The service was set up in April 2016, to support service users that receive Care Act eligible services and support and who have a learning disability.
- 7. The service provides support to people with learning disabilities to enable them to move closer to paid work and sustain employment. This is a key outcome in Worcestershire's Learning Disability Strategy as well as a nationally monitored key indicator.

#### **Equality and Diversity Implications**

- 8. The Equality Act 2010 requires Public Sector bodies, during planning, decision-making and service delivery, to give Due Regard to the three aims of the Public Sector Equality duty. These aims are:
  - a) Advancing Equality of Opportunity for people between people who have one or more of the protected Characteristics and those who do not

- b) Eliminating unlawful Discrimination, Harassment and Victimisation; and
- c) Fostering Community Relations between people who have one or more of the Protected Characteristics and those who do not.

#### Purpose of the meeting

- 9. The Panel is asked to:
  - determine whether any further information or scrutiny work is required at this stage
  - agree any comments to highlight to the Cabinet Member.

10. Arrangements are also being made for some scrutiny work on services provided for children with care needs during the transition from Children's Services to Adult Services. Due to the nature of these services, this scrutiny discussion will involve councillors involved in both adult and children's services scrutiny.

## SOCIAL WORK WITH ADULTS: STRENGTHS-BASED APPROACH

#### Summary

- 1. The Adult Care and Well-being Overview and Scrutiny Panel is to receive an overview of the Council's plans to use a strengths-based approach in social work with adults.
- 2. Representatives from the Council's Directorate of Adult Services have been invited to the meeting.

#### **Background**

- 3. A key message from the Care Act 2014 is the requirement for local authorities to 'consider the person's own strengths and capabilities, and what support might be available from their wider support network or within the community to help'.
- 4. A strengths-based approach builds on the resources and resilience that an individual already has, including family, friends and the wider community. The approach aims to turn on its head the custom and practice of current social work assessment models which start with the question: what can't you do? This will invariably lead to a focus on deficits and how the Council can provide services to meet those, rather than a conversation about how the individual and their wider networks can support and increase their own independence.
- 5. The Council is working with an innovative model called 'The Three Conversations Model' and plans to trial this from April 2017. This model involved a radical change in social work approach, putting empowerment and independence at the heart of our interactions with people. The model has evidenced in other areas better outcomes for residents, greater and sustained independence, and a reduction in spend on services.
