## **LOCAL TRANSPORT PLAN 4**

### Summary

1. The Transport, Planning and Commissioning Manager has been invited to the meeting to discuss the Local Transport Plan 4 (LTP4).

### **Background**

- 2. The Local Transport Plan 4 is part of the Council's Policy Framework and as such is required to be considered by Scrutiny and agreed by Council.
- 3. The Plan will be considered by Cabinet on 2 November 2017 and the Board will be updated on these discussions. The Cabinet report and supporting information is available here.
- 4. The LTP4 will be agreed at a meeting of full Council on 9 November 2017. The Overview and Scrutiny Performance Board's views will be made available ahead of the Council meeting.

#### The Role of the Economy and Environment Overview and Scrutiny Panel

- 5. From December 2016 to March 2017 the draft LTP4 documents were subject to an extensive public consultation exercise. As part of the consultation, the drafts were considered by the Economy and Environment Overview and Scrutiny Panel on 20 January 2017.
- 6. At the meeting, Panel Members raised a number of issues. An annotated note, showing how the issues have been addressed in the revised Plan has been circulated to current Panel Members and they have been asked to let the Chairman of the Panel have their comments, if any, to inform today's discussion.

#### Purpose of the Meeting

- 7. In the light of the discussion, the Board is asked to:
  - consider the Local Transport Plan 4 (LTP 4);
  - submit any comments to Council for consideration at its meeting on 9 November 2017; and
  - consider whether it would wish to identify any issues which should be the subject of future scrutiny.
