

## **CHILDREN AND FAMILIES OVERVIEW AND SCRUTINY PANEL 7 FEBRUARY 2018**

### **UPDATE ON OPTIMISING THE USE OF CHILDREN'S CENTRE BUILDINGS**

---

#### **Summary**

1. The Cabinet Member with Responsibility for Children and Families and the Assistant Director for Early Help and Partnerships have been invited to the meeting to update the Panel on Optimising the Use of Children's Centre Buildings.

#### **Background**

2. During 2016, a number of reports, scrutiny meetings and call-in procedures were considered by elected members as part of the decision making process on the future use and optimisation of Children's Centre Buildings in Worcestershire. The proposals included the transfer of 21 buildings to schools and other providers, and the continued use of 11 buildings for the provision of services by the Parenting and Family Support service (formerly known as Early Help services). The proposals formed part of wider discussions including the reduction in funding and redesign of early help services, the proposals relating to an integrated 0-19 prevention service (Starting Well) and the need for additional funded nursery places.
3. On 13th September 2016 the Cabinet Member with Responsibility for Children and Families published his decision in respect of the buildings included in the formal consultation carried out during the summer of 2016, and on 1<sup>st</sup> December 2016 the formal transfer process began.
4. In March 2017, the Children and Families Overview and Scrutiny Panel received the first progress update on the changes being made to the use of Children's Centre buildings (including the transfer of leases to schools and other providers) and progress towards sustaining Stay and Play provision in the county. As requested this report (and presentation) provides a further update including an progress of the transfer process, a summary of the provision at each centre and an update on the support for Stay and Play provision through the Parenting and Family Support contracts.

#### **Leases held by the Parenting and Family Support providers (formerly Early Help)**

5. Children's Centre Buildings leased to the Parenting and Family Support providers are listed in the table in Appendix 1 to this report. All leases were amended to reflect the end date of the varied contracts that is 31<sup>st</sup> March 2019.

6. Since the last update, Action for Children have decided that they no longer need the small outreach centre, Sunshine at The Grove, in Malvern and have surrendered the lease back to the Council. We are in discussion with the school, who previously expressed interest in using the facility to expand their nursery provision in response to identified need. Following a short consultation on this proposal a report from the Cabinet Member with Responsibility for Children and Families will be presented to Cabinet outlining the proposed use.

### **Transfer of centres to schools/other providers**

7. The project team managing the changes to leases at the remaining centres continues to meet weekly and comprises representatives from Children, Families and Communities (Vulnerable Children and Families commissioning team), Legal, and Place Partnership. This process of negotiating leases with schools, and dealing with routine and unexpected maintenance items, requires continuous oversight and management to avoid protracted negotiation periods where possible. The status of each transfer is noted in the table in Appendix 1 to this report. We continue to support the transition to ensure that the buildings are used to deliver early childhood services including the delivery of health services where this is appropriate.

8. The negotiation of leases is taking longer than was initially forecast in part due to delays as a result of the complexity of academy transfers both current and planned. Significant delays have also occurred due to the complexity of land ownership at a number of sites and unexpected repairs delaying transfers. In all cases there have been detailed discussions relating to the proposed leases as part of the transfer process.

### **Sustaining 'stay and play' provision**

9. During the consultation on the future use of children's centre buildings, one of the main concerns of users was the continued availability of universal stay and play sessions. These sessions allow parents and carers of children under 5 to bring their children to play sessions and to meet with other parents and carers. They also provide peer support opportunities and support access to key information advice and guidance in relation to early childhood development. The thirty thousand pounds identified to support the sustainability of universal stay and play sessions has continued to be used to provide funding for the provision or updating of equipment, to support start up costs for parent led groups and for the training and guidance of staff and/or volunteers to run sessions. As can be seen from the summary in the appendix many of the children's centre buildings are still used to host universal stay and play sessions, and many sessions continue to run in other community venues.

10. Parenting and Family Support providers continue to recruit and train volunteers to work with parents within the community using a package called 'Parents First'. In South Worcestershire for example there are 25 qualified adult volunteers from a range of backgrounds and ages. On average each volunteer gives 16 hours of support each quarter. In Redditch and Bromsgrove 3 stay and play volunteers are in place, 6 peer supporters have been trained with a further course now underway and an additional 4 volunteers are working alongside the parenting team to learn facilitation skills etc. In Wyre Forest the provider has recruited 25 volunteers with a variety of roles including running universal stay and play sessions.

## Summary

11. Overall the project of transferring Children's Centre buildings to a range of providers continues to be successful. All of the buildings continue to deliver early childhood services, in some cases increasing the range of activities on offer and/or increasing the number of nursery places available. In a small number of cases, progress on the transfers has been slow for the reasons outlined above but the project team continue to meet weekly in order to ensure that progress is maintained.

12. The next stage of the project will focus on ensuring that the proposals for individual buildings continue to be implemented, that barriers such as land ownership issues are addressed, and that where further changes in use occur these are properly consulted on.

13. In particular, during 2018 consideration will need to be given to the buildings currently leased to the Parenting and Family Support providers as plans for future delivery of the locality Early Help offer in Worcestershire post March 2019 and the Alternative Delivery Model implementation develop.

14. It is proposed that a position assessment of the Centre's is collated to include usage data, community capacity development options and multi-agency options for engaging and providing services and support to families. This information can be applied to inform decision making for 2019.

**APPENDIX 1 – CENTRE BY CENTRE SUMMARY**

32 Children's Centres buildings are within the scope of the project as listed below.

The Parenting and Family Support providers deliver services in and from 10 centres.

A further 11 centres are operated by schools and leases have either transferred or are in the final stages of being agreed and a small outreach centre has been returned to the school site.

7 centres are occupied via a lease or licence by childcare providers and negotiations are in progress with one further school who wish to expand their nursery into the centre recently vacated by the Parenting and Family Support provider.

Two centres remain wholly with the Council – in the first case the school has recently decided not to proceed with the transfer, in the second case the school have confirmed that they will be in a position to take on the lease after their academy transfer is complete.

All centres hold a range of information leaflets and posters outlining a range of support for families ranging from contact details for professionals, links to a range of useful websites (including Your Life Your Choice) and on topics relevant to under-5's.

All centres are visited at least annually in order to ensure that lease arrangements are adhered to and that buildings continue to deliver early childhood services. The first annual reviews took place in October 2017 and form the basis for the information in the activities column in the table below.
