Introduction

Overview and Scrutiny has had a busy year, looking at over 50 issues and publishing seven scrutiny reports since the last annual report. Worcestershire also successfully bid for free support from the Centre for Public Scrutiny to help the Council develop ways of involving scrutiny members in the commissioning process; this project is ongoing.

This report highlights just a few of the key pieces of work from the past year. The complete work programme can be seen at **Appendix 1.**

The remits of all the scrutiny bodies and their memberships can be found at **Appendices 1 and 2** and **Appendix 4** shows activity data.

Overview and Scrutiny Performance Board

OSPB has considered a variety of issues this year. Councillors called-in two Cabinet decisions which were determined by OSPB: Kingsford Forest Park and the consultation on passenger transport reductions, and it set up two scrutiny reviews following requests by Council: one to look at the benefits of integrating waste services, and another on food banks.

As well as considering strategic Council-wide issues such as FutureFit, the public health report and the future operating model, the OSPB has also had helpful discussions with a number of key partners in Worcestershire:

- Citizens Advice Bureau and members' concerns about its financial sustainability
- the Environment Agency in relation to flooding
- the Worcestershire Local Enterprise Partnership about the Strategic Economic Plan
- and the Hereford and Worcester Fire and Rescue Service in relation to their joint working with Warwickshire

Adult Care and Well-being Overview and Scrutiny Panel

Domiciliary Care (Homecare)

The Panel has looked at the overall domiciliary care service and also the Council's monitoring of domiciliary care providers. The Panel made suggestions for greater weighting of service user issues/complaints as part of the risk analysis process. It is likely that further scrutiny will be given to domiciliary care during 2015, potentially to look at capacity, resources and resilience of the domiciliary care market.

Children and Young People Overview and Scrutiny Panel

Positive Activities for Young People

In July 2014, Cabinet agreed that the Council's current approach to Positive Activities should be reviewed to see whether the Council could ensure sufficient local offer (in accordance with its legal duties) without any Council funding of service delivery from 2016-17. As part of the review process, the Children and Young People Overview and Scrutiny Panel was asked to comment.

The Panel met officers, the Youth Cabinet and commissioned service providers, to understand how the complexities of the planned budget reductions would impact on services. The Panel is currently pulling together its views which will be submitted to Cabinet in time for its discussion of the future of Positive Activities.

Safeguarding

In the period covered by this annual report the Children and Young People Overview and Scrutiny Panel met with the Chair of the Worcestershire Safeguarding Children's Board to discuss two of its annual reports – 2012-13 and 2013-14. Issues discussed included:

- The voice of the child
- The role of district councils in terms of their safeguarding responsibilities.
- Forced marriage and female genital mutilation.
- Safeguarding of children who are home educated.
- The complexities of gathering multi-agency data.
- Information sharing and access to data.
- The robustness of safeguarding arrangements in non-LA controlled schools, including academies, free schools and independent schools.
- Transition from children's to adult services.
- The cumulative impact of budget cuts across agencies.

Economy, Environment and Communities Overview and Scrutiny Panel

Passenger Transport

The Panel discussed the outcomes of the consultation on the withdrawal of subsidised bus services and then carried out pre-decision scrutiny on the subsequently modified proposals before they were considered by Cabinet. Members felt the impact on vulnerable people had been fairly examined and acceptable mitigations had been put in place. The Panel will continue to monitor the impact of the reductions on residents.

Trading Standards

During 2014 the Panel considered the proposed efficiency savings for Trading Standards, which amounted to £1.5 million over three years up to 2016/17. Members were concerned about the risks of reducing funding, including impacts on capacity and effectiveness and welcomed the proposal to put £185,000 back into the service for 2016/17. Members remain concerned and will continue to monitor the work of Trading

Standards.

The OSPB Chairman also represented the County Council on a joint scrutiny review of Regulatory Services.

Renewables

The Panel commented on the draft Renewable Energy Strategy for Worcestershire, which sets out how the Council will develop its own renewable energy schemes and the role that the Council could play in renewable energy generally. To get an external perspective, the Panel heard from OxFutures and Sharenergy and received a report from the Renewable Energy Foundation. Members welcomed what the Council was already doing to support renewable energy, but felt that it could do more to promote opportunities for renewable energy projects and to exert pressure on the power distribution company and the Government to try and increase capacity in the Grid.

Health Overview and Scrutiny Committee

Acute Hospital Services Review

The Health Overview and Scrutiny Committee has been taking a keen interest in the 'Future of Acute Hospital Services in Worcestershire' programme, which was launched in September 2013 to take forward the proposals outlined in the previous Joint Service Review. The Committee broadly welcomed the outcome of the Independent Clinical Review of recommendations for future service delivery, but has been very disappointed by the subsequent delay in finalising the reconfiguration of services.

The Committee has asked for regular updates on progress and in response to new developments, such as Birmingham University Hospital Trust's temporary embargo on referrals from outside the Birmingham area for some treatments and more recently, the resignation of five A&E consultants.

The Chairman also has sought assurances that clinical standards are being maintained and the Worcestershire Acute Hospital Trust remains financially sustainable during this time. Members look forward to a clear direction after the general election.

Mental Health Services

The Committee has focused on several aspects of mental health care and support, looking at services for older adults, including dementia and also the hospital based liaison service which responds to A&E referrals and to self-harm and suicide request assessments. This is an increasingly high profile policy area both locally and nationally, to which it is likely that further scrutiny will be devoted during the coming year.

Resources Overview and Scrutiny Panel

Municipal Bonds Agency

The Panel was consulted on the proposal to amend the Treasury Management Strategy in order to enable the Council to purchase shares in the Municipal Bonds Agency being established by the Local Government Association. The Municipal Bonds Agency would raise finance by issuing bonds and lend it on to local authorities. If successful the Agency could provide loans to local authorities at rates below the Public Works Loans Board (PWLB). The Panel was supportive of the initiative and suggested there be a limit

to the amount which one authority could borrow, and that the Council is well represented on the Agency Board.

Smarter Working

The Panel has been monitoring the progress of the Streamlining Management project, which is expected to make up to £3m savings. Members were pleased that layers of management had been reduced from 8 to 5 or 6 in most Directorates, although they are keen to understand the impact of this on frontline staff and level 1 and 2 managers and will continue to look at staffing issues in 2015-16.

Food Banks Scrutiny Task Group

Following a Notice of Motion at full Council, the OSPB agreed that a Scrutiny Task Group should be set up to look into food banks in the County.

Members heard strong evidence that benefit delays and sanctions were major factors behind the increasing demand for food banks. The task group's report was sent to all County MPs with a request that they contact the Department for Work and Pensions to seek data on benefit withdrawal and sanctions, and helpful responses were received from several MPs.

Budget Scrutiny Task Group

This year the OSPB agreed a new way to scrutinise the 2015/16 budget. It was agreed that a scrutiny task group should be set up to examine budget issues across the whole council and talk to a variety of witnesses to enable a fuller analysis to be put to Cabinet in February 2015.

The task group made a number of specific recommendations and highlighted several areas of concern. Although Members were pleased to hear that each savings project was being fully assessed to establish its impact on equality, they were concerned about the cumulative effect of the savings, particularly on those who were from socioeconomically deprived communities. The Task Group was also concerned about the proposed removal in 2016/17 of the budget for positive activities and the financial impact this might have in other areas of the Council's work.

Libraries Scrutiny Task Group

Following member concerns about the future outcomes for the mobile library service, a pre-decision scrutiny task group looked at the proposals before they were considered by Cabinet in July 2014.

Overall, the Task Group was impressed with the savings plan for fixed libraries and pleased that the County Council will continue to deliver, and be responsible for running, the full library service. They considered that provision of a mobile service only outside a 3 mile radius of fixed libraries was reasonable, and made a number of recommendations to explore how an enhanced service could be achieved and suggested questions to incorporate into the consultation. The Task Group suggested a future review to find out users' views on the quality of service and establish the level of drop off.

Digital Inclusion Scrutiny Task Group

The scrutiny examined how the Council would ensure that all Worcestershire residents benefit from the opportunities offered by its Digital Strategy and aimed to identify possible risks and how these can be mitigated.

Members stressed the importance of the Council working with residents to "co-produce" digital inclusion and clearly communicating the aims of the strategy, and the fact that face to face and phone contact would continue to be available for those with complex needs or without access to online reporting. Sufficient resourcing for these alternative channels must also be kept in place. The OSPB agreed that members should monitor implementation of the Digital Strategy.

Integrated Waste Service Scrutiny Task Group

Following a Notice of Motion at Council, a Scrutiny Task Group was set up to investigate the potential for introducing an integrated waste collection and disposal service in Worcestershire, and examine potential costs, savings, benefits and barriers.

The Task Group found that, while combining operations could bring financial benefits, it was essential that there was a strong desire from at least one of the participating authorities. In Worcestershire there are few signs that such desire exists. However, the scrutiny established that there would only be a desire to integrate waste services if significant savings could be guaranteed for all partners. Given this, the task group recommended an audit is conducted to find out what savings might be made.

Reducing Crime against People at Risk

This Scrutiny Task Group investigated how the County Council, with partners (including the Police), can reduce crime against people at risk, including Domestic Violence, Hate Crime, Honour Based Violence/Forced Marriage.

The Scrutiny found that the amount of domestic violence, hate crime and honour based violence in Worcestershire is relatively low, but available data must be seen as the tip of the iceberg, given reluctance to report incidents. There was a huge amount of excellent work being undertaken across Worcestershire but it was not possible to gain a clear picture of how such work was funded (e.g. where County Council funding is directed), whether the funding was appropriate, and how to support planning for the future.


