Background

2. This is the second JSNA annual summary presented to the Health and Well-being Board since the update of the Health and Well-being Strategy in 2016. It pulls together information relating to the three priorities:

- Keeping active at every age
- Preventing alcohol harm at all ages
- Good mental health and wellbeing at all ages

3. Alongside this information are brief summaries of some issues that are either starting to show some potential problems locally or that are likely to lead to possible issues in the future.

4. The emerging issues that have been identified are:

- The narrowing gap between Worcestershire and England;
- Infant mortality;
- Drug misuse deaths;
- Excess weight and diabetes;
- Violent crime;
- Homelessness;
- Autistic Spectrum Disorder (ASD)

5. Finally the report includes a brief summary of JSNA outputs that have been published over the last year and where these can be found on the JSNA website.

6. Health impact assessment: This report does not contain details of policy change, and so a health impact assessment does not apply. The data presented provides information for decision making around health equity. This includes consideration of protected groups including age, sex, race, pregnancy & disability.
