7. RE News Update.

Purpose of Report

1. To update SACRE about national RE news, events and issues.

Background

2. GCSE and A Level reform

The National Association of Teachers of RE (NATRE) and The Religious Education Council (REC) are delighted that the Department for Education has accepted the case for the reform of GCSE and A level examinations in the subject on the same timescale as EBacc subjects such as History and Geography, with first teaching from 2016. One of the recommendations of the REC Review (2013) was to "promote coherence and progression between 4-14 programmes of study and 14-19 public examinations" and this reform is an ideal opportunity to work towards that aim. The Qualifications Committee of the RE Council are currently revising the criteria for the GCSE and A-level specifications, prior to them being approved by the DfE and Ofqual, and then sent to exam boards who will use them to design their new exam specifications.
