DISCLOSING INTERESTS

There are now 2 types of interests: 'Disclosable pecuniary interests' and 'other disclosable interests'

WHAT IS A 'DISCLOSABLE PECUNIARY INTEREST' (DPI)?

- Any **employment**, office, trade or vocation carried on for profit or gain
- **Sponsorship** by a 3rd party of your member or election expenses
- Any **contract** for goods, services or works between the Council and you, a firm where you are a partner/director, or company in which you hold shares
- Interests in **land** in Worcestershire (including licence to occupy for a month or longer)
- **Shares** etc (with either a total nominal value above £25,000 or 1% of the total issued share capital) in companies with a place of business or land in Worcestershire.

NB Your DPIs include the interests of your spouse/partner as well as you

WHAT MUST I DO WITH A DPI?

- Register it within 28 days and
- **Declare** it where you have a DPI in a matter at a particular meeting
 - you must not participate and you must withdraw.

NB It is a criminal offence to participate in matters in which you have a DPI

WHAT ABOUT 'OTHER DISCLOSABLE INTERESTS'?

- No need to register them but
- You must **declare** them at a particular meeting where:
 - You/your family/person or body with whom you are associated have a **pecuniary interest** in or **close connection** with the matter under discussion.

WHAT ABOUT MEMBERSHIP OF ANOTHER AUTHORITY OR PUBLIC BODY?

You will not normally even need to declare this as an interest. The only exception is where the conflict of interest is so significant it is seen as likely to prejudice your judgement of the public interest.

DO I HAVE TO WITHDRAW IF I HAVE A DISCLOSABLE INTEREST WHICH ISN'T A DPI?

Not normally. You must withdraw only if it:

- affects your pecuniary interests OR relates to a planning or regulatory matter
- AND it is seen as likely to prejudice your judgement of the public interest.

DON'T FORGET

- If you have a disclosable interest at a meeting you must disclose both its existence and nature – 'as noted/recorded' is insufficient
- Declarations must relate to specific business on the agenda
 - General scattergun declarations are not needed and achieve little
- Breaches of most of the **DPI provisions** are now **criminal offences** which may be referred to the police which can on conviction by a court lead to fines up to £5,000 and disqualification up to 5 years
- Formal dispensation in respect of interests can be sought in appropriate cases.

REFRESH OF THE SCRUTINY WORK PROGRAMME

Summary

1. The Overview and Scrutiny Performance Board (OSPB) is asked to consider the Scrutiny Work Programme for 2024/25, prior to it being submitted to Council for approval.

Developing a Scrutiny Work Programme

- 2. The current 2023/24 Scrutiny Work Programme was agreed at Council on 18 May 2023. It is now timely for the work programme to be refreshed for the coming year. The refreshed work programme will be considered by full Council on 16 May 2024.
- 3. In preparation for this meeting, Panel Chairmen have consulted with their Scrutiny Panels, relevant Cabinet Members with Responsibility and Directors on any amendments they would like to make to their work programme. Draft Work Programmes for the Board, Panels and Health Overview and Scrutiny Committee (HOSC) are attached at Appendix 1.
- 4. Members are reminded that the Council's Constitution includes a requirement for the OSPB (using the Panels where appropriate) to receive, comment and advise on the Council's policy framework.
- 5. The Board is also asked to consider whether, in addition to the Policy Framework and standing items it considers, there are any other issues that should be added to its Work Programme.
- 6. In determining its Scrutiny Work Programme, the Board needs to consider a number of points.

Issues suitable for scrutiny

- 7. The Board has agreed to use the following criteria to help determine its scrutiny programme. A topic does not need to meet all of these criteria in order to be scrutinised, but they are intended as a guide for prioritisation.
 - Is the issue a priority area for the Council?
 - Is it a key issue for local people?
 - Will it be practicable to implement the outcomes of the scrutiny?
 - Are improvements for local people likely?
 - Is there any evidence to it is a poor performing service?
 - Will it result in improvements to the way the Council operates?
 - Is it related to new Government guidance or legislation?

- 8. In considering the proposed work programme Members should also aim for it to be:
 - balanced, in terms of some topics being of longer duration and some being suitable for shorter study
 - Mixed in terms of covering different topics/directorates
 - Not so onerous that there is no flexibility and room left for smaller, additional items such as Call-ins, to be added in at a later time if the OSPB regards it as a priority, and
 - Taking account of the resources available to support scrutiny.

Purpose of the Meeting

- 9. The Overview and Scrutiny Performance Board (OSPB) is asked to:
 - consider the reports from Panel Chairmen on potential work programme topics;
 - consider whether there are any issues which should be added to the OSPB's Work Programme;
 - determine the Scrutiny Work Programme for 2024/25 to be considered by full Council.

 - Health Overview and Scrutiny Committee (HOSC) Brandon Clayton
 - Crime and Disorder Richard Udall
- 5. To assist in their role, scrutiny lead members have the benefit of regular briefings from the Directorates they are shadowing, something which was put into place by the Strategic Leadership Team (SLT). These briefings, alongside the Cabinet Forward Plan (see below), can be used to help identify any emerging issues that may be appropriate for future scrutiny. Recognising that work across the County Council is of interest and value to all Board members, the notes from these briefings (where produced) are available to all members electronically.
- 6. The main responsibilities of the Board are:
 - Commissioning work for Scrutiny Panels
 - Establishing Scrutiny Task Groups (agreeing Terms of reference and Reports)

- Advising on Council's Policy Framework ie Sustainable Community
 Strategy (if any), Corporate Plan, Children and Young People's Plan, Local
 Transport Plan, Youth Justice Plan, 'Act Local in Worcestershire'
 framework, such other plans and strategies as required by law to form part
 of the Policy Framework or which may be and have been adopted to be
 part of that Framework eg Corporate Plan, Budget
- Call-ins
- Designated by the Council as its statutory Crime and Disorder Committee and must meet at least annually.
- 7. The Board agreed to use a set of criteria (listed below) to help determine its scrutiny programme. A topic does not need to meet all of these criteria to be scrutinised, but they are intended as a guide for prioritisation.
 - Is the issue a priority area for the Council?
 - Is it a key issue for local people?
 - Will it be practicable to implement the outcomes of the scrutiny?
 - Are improvements for local people likely?
 - Does it examine a poor performing service?
 - Will it result in improvements to the way the Council operates?
 - Is it related to new Government guidance or legislation?

Scrutiny Task Groups

- 8. Board Members recently discussed new ideas for topics to be scrutinised in detail. A 'Review of the Council's spend on Consultants, Locums, Temporary and Agency staff' was agreed as the preferred topic to be taken forward. It is suggested that this work commences when the structural reorganisation of the Council has been completed. An intensive Select Committee style scrutiny exercise on this topic will therefore be planned for the Autumn and will take place over the course of a couple of days.
- 9. In the meantime, alternative suggestions for topics for a Scrutiny Task Group have been sought from Board Members.

Cabinet Forward Plan

10. The Board will wish to consider any issues arising from the Council's Forward Plan. The latest version of the Plan available at the time of Agenda despatch is attached at Appendix 1 for consideration.
