




Responsible Investment Summit Feedback



How could sessions be improved / developed?



	<ul style="list-style-type: none">• Factor Investing session too confusing• The RI index from FTSE Russell was highlighted as the solution to problems – only a measurement tool and not an easy one to operate. Most discussion was dipping between high level theoretical and low level anecdotal• No criticism of the speakers on Factor Investing but they had impossibly little time to explain it to an audience who aren't mathematicians/statisticians• Afternoon session lacked clarity• Need to keep time for the sessions• Better timing• Keep speakers to time (though could have listened to Church of England man for longer)• Would have liked more time for questions• Too many speakers meaning little time for questions• More time for discussions on tables• Some speakers were dull and uninspiring and got bogged down and sketchy on overall strategy• A larger variety of engaging speakers would have been advantageous• This is not the day job for some people – keep the language as basic as possible• Ban jargon• Would be useful to have in-depth info to download

Do you feel more engaged on RI as a result of the event?




■ Yes (34) ■ No (0)

Do you feel the event was well structured?




■ Yes (34) ■ No (1)

Was the venue easy to find?


