# PROPOSED DELIVERY MODEL FOR MEDICAL EDUCATION PROVISION IN WORCESTERSHIRE

#### **Summary**

1. The Cabinet Member with Responsibility for Education and Skills and the Director of Education and Early Help have been invited to the meeting to update the Panel on the proposals for the delivery model for medical education provision in Worcestershire being considered at Cabinet on 18 March 2021.

## **Background**

- 2. Consideration of the review of Medical Education Provision is part of the Panel's Work Programme and it has received updates on the review of the service at its meetings on 23 January 2020, 16 June 2020 and 13 November 2020.
- 3. The Medical Education Team (MET) is a service delivered by Worcestershire Children First (WCF), providing education for children who are unable to attend school because of medical needs including mental health difficulties.
- 4. On the 30 January 2020 Cabinet received a report from WCF proposing a review of Medical Education Provision in Worcestershire. The report set out the context and case for change on behalf of Worcestershire children and young people. The January Cabinet report set out limitations in the service including those identified by external peer review in 2018.
- 5. The latest report that the Panel received (13 November 2020) set out the findings of the review including feedback from stakeholders, along with the proposed pathway and outcomes.

#### **Next steps**

- 6. A presentation outlining the proposals for the delivery model is attached at Appendix 1.
- 7. A report detailing proposals for a new model of delivery for medical education provision will be considered at Cabinet on 18 March 2021 (attached as Appendix 2).
