(ii) DEVELOPER-FUNDED HIGHWAYS INFRASTRUCTURE

#### Summary

1. The Overview and Scrutiny Performance Board (OSPB) is asked to consider and approve the attached draft scrutiny reports on Child and Adolescent Mental Health Services (CAMHS) and Developer-funded Highways infrastructure.

#### Background

#### <u>CAMHS</u>

- 2. In 2019, the Children and Families Overview and Scrutiny Panel identified the services supporting the mental health of children and adolescents in the County as a priority for scrutiny. In December 2019, the Board agreed to set up a Scrutiny Task Group to look into this area. Unfortunately, this work was interrupted by the Covid-19 pandemic and was restarted in December 2021.
- 3. The Terms of Reference for the scrutiny exercise were 'to investigate access to and the availability of appropriate mental health services for children and adolescents'.
- 4. The Task Group was initially led by Councillor Kyle Daisley until May 2022 when he was appointed as Vice-Chairman of the Council and Councillor Steve Mackay took over this role.

#### **Developer-funded Highways Infrastructure**

- 5. During its performance monitoring process, the Council's Environment Overview and Scrutiny Panel (previously known as the Economy and Environment Overview and Scrutiny Panel) expressed concern about the length of time taken for developer-funded highways infrastructure, mainly housing development, works to be completed. Specific areas of concern include the length of the overall process and the time taken for the Council to approve planning submissions from developers. The delay in completing developer-funded highways infrastructure works impacts on local communities, road users and businesses, therefore this area was identified as a priority for further scrutiny.
- 6. In January 2021, the OSPB agreed that a Scrutiny Task Group led by Councillor Alistair Adams should be set up to look at this area. Due to the Covid-19 pandemic, and subsequent impact on scrutiny priorities, this work commenced in October 2021.

- 7. The Terms of Reference for the scrutiny exercise were to investigate:
  - How to get developer-funded highways infrastructure built quicker for the benefit of residents and road users
  - How the Council can help ensure the planning conditions imposed on developers to build key highways infrastructure by certain deadlines are met.

## **OSPB's Role**

- 8. One of OSPB's roles is to monitor the quality of scrutinies that are carried out to ensure that scrutiny reports are robust, and evidence based, and that they follow the terms of reference agreed by the OSPB.
- 9. To help with this, the OSPB has received regular verbal updates on the progress of the scrutiny from the Lead Members of the Task Groups.
- 10. Once the Board is content, the Scrutiny Reports will be considered by Cabinet at its meeting on 30 March 2023.
